According to law 675/1996 AIM Congress - Aim Group, with registered office in Milan, Via Ripamonti 129 (The Company), as treatment holder, inform you last the providing of your personal data is voluntary, but non acceptance of personal data processing will prevent your participation to the congress. The personal data are treated for purposes correlated or instrumental to the performances related to your participation to the congress and also for free delivery of documentation related to other congresses or initiatives of the Company or of the other companies of the AIM Group. Such treatments are performed through manual elaboration or electronic or automated instruments, in a manner which is strictly correlated to the aim pursued and guarantees the confidentiality and the security of personal data.
